Possesses a Ph.D. Degree who was registered for the Ph.D. Programme Prior to 11 July 2009 from any University recognized by the UGC, New Delhi only on the condition that such a candidates submits a Certificate from the Vice-Chancellor/Pro-Vice Chancellor/Concerned Dean of the University concerned mentioning therein that (a) Ph.D. Degree awarded to the candidate in regular mode only, (b) evaluation of the Ph.D. thesis by a least two external examiners; (c) Open Ph.D. vice-voce has been conducted; (d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in a referred journal; (e) Candidate has made at least two presentations in conferences/ seminars, based on his/her Ph.D. work.
